Anyone who has been touched by violence against women and who has the permission of the individual directly affected by the violence for the design of the tee-shirt. This permission is necessary in order to help insure that the privacy of the survivor and her loved ones is respected. We greatly appreciate the return of the form included in this pamphlet with completed teeshirts.

commemorate a survivor, written permission from the survivor is required. Full name and address are not necessary.

To commemorate someone who has been killed, written permission from the victim's family is required, along with the victim's name; date of birth, date of death and the victim's hometown may also be included.

Any other information concerning the victim is not necessary; but it would be greatly appreciated in order to further personalize each woman's story (such as a paragraph explaining the story behind the shirt and its significance in your life, a photograph, etc.).

# WHAT (AN I CONTRIBUTE

We are asking people to contribute a shirt of their own design to memorialize a woman who has been a victim of violence. We prefer that shirts conform to the national color code so that the visual impact of the Clothesline, when shown together with other organization's Clotheslines, can be strong and clear.

White: Fatal assault (including

Red/Pink/Orange: Rape or sexual assault Vellow/Tan/Brown: Physical and/or emotional

To increase the durability of these shirts you are encouraged to:





NWROC -- WHO WE ARE

The National Women's Rights Organizing Coalition (NWROC) is a national, militant left-wing women's rights group founded in 1990 by local abortion clinic defense organizations which have been stopping OR at the clinic doors and building mass mobilizations to defend reproductive rights since 1987. Our experiences of the last few years and the failure of the NOW/NARAL strategy in Wichita have convinced us that it is suicidal to rely in any way on injunctions, cops or the courts in defending our rights. It is obvious to all that the Republicans are the enemies of abortion rights. But many Democrats (such as the Democratic Mayor of Buffalo, who invited OR with open arms) are also the enemies of abortion rights. Even the pro-choice Democrats have made it clear that they are prepared to do next to nothing to defend abortion rights. We must build political action and a workers' party to defend abortion rights, independent of the sexist Republicans and Democrats and their corporate backers. We believe the women's movement must actively fight racism and antigay bigotry and address economic concerns such as jobs and social service cuts if it is to overcome its historic isolation from other struggles and have the strength to win its demands.

We wish to work with any and all individuals and groups who want to stop OR in Buffalo, regardless of whether or not they agree with our full program. We invite everyone who wants to defend Roe v Wade to join with us in Buffalo and send a loud message to the Supreme Court that

we will not sit by quietly and watch our rights slip through our fingers.



### 8 abortion protesters charged with contempt

CAMBRIDGE - Eight abortion protesters have been charged with criminal contempt for ignoring an October 1991 court injunction that prohibits the blockade of abortion clinics.

The indictments stem from two abortion clinic blockades this summer, one at a Hyannis facility, the other at a Boston clinic.

In the demonstrations, protesters locked themselves to a block of cement and chained themselves inside a disabled van.

Indicted by a Middlesex County grand jury were: Richard J. Cormier of North Quincy, Francis Hagerty of Dorchester, Mary Kelliher of Wellesley, John D. McCarthy Jr. of Waltham, Thomas Carleton of Arlington, Kevin Cleary of Grenshaw, Pa., Robert Delery of Medford and

Catherine Wommack of Roxbury.

According to the attorney general's office, both Carleton and Hagerty are priests. Carleton is not assigned to a parish in the area, they said, and Hagerty is a math teacher at Boston College High School.

On July 18, protesters allegedly disabled a van and parked it in front of the Gynecare Clinic on Tremont Street in Boston. The tires were flattened and the doors welded shut. The floor of the van had been removed so that protesters could lock themselves to the front axle.

On June 27, 28 protesters allegedly blocked the front entrance to the Woman Care Clinic in Hyannis by lying down and locking their heads and necks to a large block of cement.


